



Sarasota County Supervisor of Elections Vote-by-Mail Ballot Request Form

You may request a vote-by-mail (absentee) ballot by completing this form and mailing it to the address at the bottom of the form.

Before you request a vote-by-mail ballot, you should know the following:

- You must be registered to vote in **Sarasota County** by the registration deadline, 29 days before Election Day
- Requests for ballots to be mailed are not accepted after 5:00 pm six days prior to an election
- Voted ballots **must be received** in the elections office **by 7 p.m. on Election Day**.

All written requests for vote-by-mail ballots **must be signed**. We cannot process a request unless it includes **ALL information in sections 1-5** below and **voter signs section 6**, except if request is being made by **someone other than the voter**. (See below) **One request is good for all elections through the end of the calendar year of the second ensuing regularly scheduled General Election.**

NOTE: Vote-by-mail ballots cannot be forwarded by the US Post Office, nor will they be held. If a ballot is returned to the supervisor of elections by the USPS as undeliverable, all future vote-by-mail ballot requests will be canceled until the supervisor is contacted by the voter. A request for a ballot to be mailed to an address other than the voter's address on file with the elections office must be signed by the voter.
